## YOUTH GUEST WAIVER

### WAIVER AND RELEASE FROM LIABILITY

I, \_\_\_\_\_, HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge Coastal Georgia Gun club, Inc. ("CGGC"), its agents, employees, officers, directors, affiliates, successors and assigns of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, arising from or in any way related to my or my child's participation in any of the events or activities conducted by, on the premises of or for the benefit of the CGGC, provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

I fully understand that the activities that I or my child will be participating in or observing may be inherently dangerous and pose a risk of serious bodily injury or death. On behalf of myself, my heirs, assigns and next of kin, I waive any claims for damages, injuries, and/or death sustained to me, my child or my property that I may have against the aforementioned released party(ies) to such activity.

By this Waiver, I assume any risk, take full responsibility for and waive any claims for personal injury, death or damage to personal property arising directly or indirectly from any activity conducted, organized, sponsored by CGGC or otherwise taking place on its property in which I choose to participate or observe or permit my child to participate in or observe.

The provisions of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of or for the benefit of CGGC, whether by agreement, by operation of law, or otherwise.

I have read, understand and fully agree to the terms of this WAIVER AND RELEASE. I understand and confirm that by signing this WAIVER AND RELEASE I have given up considerable future legal rights. I am signing this Agreement freely, voluntarily, under no duress or threat, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law.
