# Application Procedures and Fees

## **Club meetings scheduled for first Thursday of each month.**

The following items must be submitted to the Secretary at the introductory meeting:

- \_\_\_ Completed and signed application form.
- \_\_\_ Completed and signed waiver form.
- \_\_\_ Proof of the applicant's legal ability to own firearms (carry permit or background check).
- \_\_\_ Payment in full of first year's membership (pro-rated as applicable – see below).
- \_\_\_ Proof of NRA membership.

During the introductory meeting, the Sponsor will introduce the applicant. The Sponsor (and co-sponsors) must be willing and able to attest to the applicant's ability to handle firearms in a safe and responsible manner. The sponsor (and/or co-sponsors) and applicant must be prepared at the introductory meeting to answer questions pertaining to the applicant's background and membership requirements. The applicant's name will then be published in the monthly Club newsletter as applying for membership to the Club.

The Sponsor or co-sponsor must attend the following month's meeting to again speak for the applicant prior to a vote on the applicant's membership request. The applicant will not attend this meeting. If the Sponsor or a co-sponsor is not present at that meeting, the vote will be postponed for one month only. If the Sponsor or a co-sponsor is not present at the second month's meeting, the applicant's paperwork and fees will be returned to him. He will be allowed to begin the application process again at a later time that is more convenient to him and his Sponsor.

Within 10 days of voting by the members, the Secretary will mail the applicant a letter stating the outcome of the voting and giving information on scheduling an orientation. A membership card and gate combination will be issued upon completion of orientation. If the applicant's request for membership is denied the Secretary will return all paperwork and fees to the applicant.

### Reinstatements:

Any member whose dues have lapsed by less than 1 year may be reinstated by completing the application form (no sponsor is required), showing proof of NRA membership and ability to own a firearm, and paying the current year's dues (not pro-rated) and a reinstatement fee of \$100.00. Once all fees and paperwork have been received, the Secretary will mail a letter containing information on scheduling an orientation. A membership card and gate combination will be issued upon completion of orientation.

Any member whose dues have lapsed by 1 year or more must complete the application process as a new member (including having a sponsor, 2 co-sponsors and showing proof of legal ability to own firearms and membership in NRA) and be introduced and voted upon as described above.

### Orientation:

All new applicants and reinstated members must attend orientation. Orientations are held on workdays at the Club. A membership card and gate combination will be issued upon completion of orientation.

Fees: Membership dues are as follows and will be pro-rated based on the date of application as follows:

**JUNIOR MEMBERSHIP..... \$ 20.00**  
(No voting privileges. Must be accompanied by a Senior or Associate Member at range.)

**REINSTATEMENT FEE:.....\$100.00**  
(Also applies to renewals after October 31 of each year.)

**ANNUAL SERVICE FEE:.....\$ 50.00**  
(Waived for new applicants and with any approved service.)

**LIFE MEMBERSHIP = TEN (10) TIMES CURRENT SENIOR MEMBERSHIP (Must be life member of NRA)**

\*Date of application, not date of membership, is used to calculate pro-rated dues amount.
